WHEREAS, Engrossed Second Substitute Senate Bill 5237 Child Care and Early Learning, including various provisions became effective in part on May 7, 2021; July 1, 2021; and July 25, 2021, with remaining provisions becoming effective on July 1, 2024 and July 1, 2016; and

WHEREAS, Engrossed Second Substitute Senate Bill 5237 established in Revised Code of Washington (RCW) 43.206.692 Family Home Providers - Capacity Flexibility, providing the Washington State Department of Children, Youth, and Families authority to waive the limit that restricts family home providers from serving not more than 12 children; and

Section 3. Amendments to Redmond Zoning Code (RZC) Section 21.08.340 Home Business. The provisions of RZC Section 21.08.340, paragraph C. Requirements., subsection 13. Family Day Care Providers. are hereby amended to read as follows:

RZC 21.08.340 Home Business.

C. Requirements. The following standards shall apply to all home businesses. An applicant wishing to apply for a business license for a home business must demonstrate compliance with these standards prior to obtaining a business license.

13. Family Day Care Providers.

a. Family day care providers are permitted as home businesses as permitted or limited by the underlying zone.

- b. Family day care providers [SHALL] must obtain a business license and maintain the City of Redmond license as long as the use operates.
- c. The family day care provider [SHALL] must not care for more than 12 children at any time or as licensed pursuant to a waiver granted by the Washington State Department of Children, Youth, and Families per Chapter 43.216 RCW and Chapter 110-300 WAC, now or as hereafter amended.
- i. Family day care providers encouraged to request from the City of Redmond preapplication review of proposed waivers to the number of children to be cared for at any time in advance of application to the State.
- d. Family day care facilities are required to adhere to all standards prescribed in this section for home businesses, except that:

i. Family day care facilities are exempt from the limitations on business traffic to and from the facility as specified in subsection C.7 of this section.

ii. The amount of gross floor area within the principal dwelling unit that may be devoted to the family day care business [SHALL] must be the minimum number of square feet required by the State[, OR 25 PERCENT OF THE TOTAL GROSS FLOOR AREA, WHICHEVER IS THE GREATER].

iii. Family day care providers may have two additional employees on the premises at a time outside the family group that reside on the premises engaged in the family day care home business.

A. Family day care providers may exceed two additional employees outside the family group up to the number of employees required to comply with the terms of the waiver issued by the State.

e. Family day care providers may operate from 5:30~a.m. to 9:00~p.m.

f. Family day care providers [SHALL] must comply with all building, fire, safety, and health codes.

i. Family day care providers that receive a waiver from the state to increase the number of children permitted under the terms of their license must request an inspection from the City of Redmond, and any other agencies with jurisdiction, to confirm that operations comply with all building, fire, safety, and health codes. This inspection must be performed, and compliance with applicable building, fire, safety, and health codes must be confirmed in advance of the operation receiving an updated business license.

g. Family day care providers [SHALL] must obtain all required state approvals. The State shall certify that the proposed family day care provider will have a safe passenger-loading area. The family day care provider [SHALL] must provide the City with a copy of the state license.

Section 4. Severability. If any section, sentence, clause, or phrase of this ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such
